INSTRUCTIONS

- 1. Enter the name of the elector organization.
- 2. Enter any abbreviations, acronyms or other names the elector organization is known as and which name will be used on the ballot during elections.

Enter all jurisdictions where the elector organization will endorse candidates (e.g., Saanich, Saanich School District, Capital Regional District).

IMPORTANT NOTE: All of the names of a registered elector organization are subject to certain restrictions. For instance, the elector organization name cannot include information that is prohibited from appearing on a ballot, such as an indication that a candidate is holding or has held an office, identification of a title, honour, degree, decoration or the occupation of a candidate. In addition, an elector organization name (including abbreviations or acronyms) cannot be similar to the name of an elector organization in that jurisdiction that is currently registered, has an earlier application for registration pending, or if in the B.C. Chief Electoral Officer's opinion, the name is likely to be confused with another elector organization in that jurisdiction registered at any time during the previous four years or that has appeared on a ballot during the previous 10 years. If your elector organization has a "prohibited" name, registration will not be approved. For more information on elector organization names, please refer to the Guide to Elector Organization Registration and section 30.08 of the *Local Elections Campaign Financing Act*.

If a registered elector organization wishes to change their name or add a new name, the approval of the B.C. Chief Electoral Officer is required to ensure that it is not a prohibited name.

- 3. Enter the address where the elector organization's financial records will be maintained into Part B and enter a person's name who can be contacted in relation to record-keeping.
- 4. Enter the names and contact information for the Authorized Principal Official and Responsible Principal Official into the boxes in Part C. These individuals must sign their names in their signature box. The authorized principal official must be the same person who signs the Elector Organization Registration Authorization form (4461). If there is more than one responsible principal official, please attach additional sheets.

The authorized principal official's information must be published in the B.C. Chief Electoral Officer's public register of elector organizations.
