



Part 11 – Looking Ahead

A. Delivery of this Preliminary Report

The legislation that governs us requires that we submit this report to the Speaker of the Legislative Assembly by August 15, 2007. The Speaker must promptly cause the report to be made public.

This report is also available in electronic format (DVD) from the commission office (see back page for address), and on our commission website (www.bc-ebc.ca).

B. Public Hearings

After this report has been made public, section 11 of the *Electoral Boundaries Commission Act* requires that the commission "hold hearings at the places and times it considers appropriate to enable representations to be made by any person as to the area and boundaries of any proposed electoral

district." This includes our proposed SMP and BC-STV electoral districts. We must give reasonable public notice of the time and place of our public hearings.

C. Dates and Locations of our Public Hearings

F. The Commission's Final Report

Following our public hearings, we will make any amendments we consider advisable and incorporate them in a final report, which must be submitted by February 15, 2008 to the Speaker of the Legislative Assembly or, if the Legislative Assembly is not then in session, to the Clerk of the Legislative Assembly, who must promptly cause our final report to be made public.

Section 13(1) of the legislation provides that our final report must:

- (a) if the Legislative Assembly is in session when the report is submitted, be promptly laid before the Assembly, or
- (b) if the Legislative Assembly is not then in session, be laid before the Assembly within seven days after the commencement of the next ensuing session.⁷⁰

G. The role of the Legislative Assembly

Our commission's proposed electoral boundaries are only proposals. The final decision respecting adoption of our proposals rests with the Legislative Assembly. Section 14 of the legislation states:

If the Legislative Assembly, by resolution, approves or approves with alterations the proposals of the commission, the government must, at the same session, introduce a bill to establish new electoral districts in accordance with the resolution.

⁷⁰ The legislation refers to "the report" and "any amendments to the report." In this report we have used the term *Preliminary Report* to refer to "the report," and we will include "any amendments to the report" in our final report. Our final report will include everything that is contained in this *Preliminary Report*, plus any additional material that the commissioners consider necessary arising out of our formal public hearings in the fall of 2007. By incorporating everything from our *Preliminary Report* into our final report, readers of the latter will not have to refer back to the former for a full understanding of our commission's work. Similarly, it will only be necessary for our final report to be laid before the Legislative Assembly.
