GENERAL INSTRUCTIONS

5. Enter electoral district or jurisdiction relevant to filing, if applicable.
6. Enter name of individual making request.
7. Enter position of individual making request.
8. Enter original deadline date.
9. Enter proposed new deadline date. If accepted, this is the latest date without penalty the new report may be filed.
10. List reasons for extension request. Extensions are only granted in emergencies or extenuating circumstances.
11. Document a work plan to resolve the outstanding issues by the proposed new deadline date (optional).
